# Worship

I created a sermon series for each liturgical season. Our music went through a lot of changes. We also had a special services like Good Friday, Worship in the Park, a Pet Blessing, a Gratitude Sunday, the Longest Night and Christmas Eve with candlelight.

# Spiritual formation

Church Council attended a leadership retreat to learn about nonviolent communication. I led an Enneagram workshop in March. I read several books on church revitalization. We had a successful Adult VBS in July. I did some group study with Council on "Real Good Church" by Molly Baskette. I had Office Hours in the Fall. And brought in the labyrinth in December.

# Leadership

We re-established the Missions Board with Jan Hinkley as chair and Linda O'Riley, Arlene Penman, Ellie Bursaw on the committee. The Place, Pantry, WSC, 5 for 5, Heifer International are all a part of our mission. I hired a new custodian, book keeper and interim music director. I have been building leadership capacity among our Council. I was called as the minister of CCC on October 22. I had a New Members Social Hour and welcomed 7 new members in November.

I also have a group of people who are interested in visiting people who cannot get to church.

# Welcoming Spaces

We had 5 rooms that were used as storage. We did some major purging so that we could make more of the church usable and with less clutter. We moved the offices from the parsonage to the main church building. I also established the HUB for member information and a Welcome Desk for guests. I also improved the signage around the church for people who are visiting for the first time.

# Communication





# **Moderator's Annual Report**

Greetings everyone! This quote from Prime Minister Sunak feels relevant to me today. PM Sunak's approval rating is recently a bit low. ## Treasurer's Annual Report and Financial Status Summary

I started my first term as Treasurer at the beginning of 2023. During the year, I provided monthly reports to the Council, worked with the bookkeeper, and oversaw withdrawals from our investments fund. In October, I was hired as the accountant and, due to the conflict in duties with both roles, my term as Treasurer has come to an end. I'm looking forward to working with church leadership in 2024!

The Balance Sheet summarizes our financial position at the end of 2023. Withdrawals from UC Funds investments for the year totaled \$55,000, leaving a balance in that account of \$48,896 which represents money put into "designated" and "restricted" funds over the years. I've included a summary of each of the funds which provides an explanation of what the money was to be used for and recent activity. The Church Council and Trustees have been discussing the idea of adding these funds to our operating budget. (These funds are separate from the Smith Scholarship Funds which have been with JP Morgan Chase.) After much due diligence and discussion with Dan Stuart and Andy Kovats to determine if these funds could be "un-designated/unrestricted", it was determined that most of the money could be put into the Church's general fund by a vote of Church Council.

The proposed 2024 budget shows the numbers with and without having the funds. In both cases, we still have a deficit budget although it is considerably smaller with the undesignated/unrestricted funds. On Sunday, January 21, 2024, Council voted to add the funds to our operating budget and to present that budget to the congregation for approval. Some other things to note:

- We ended 2023 with a net loss of (\$56,641), almost \$11,000 under budget from the (\$67,466) net loss originally projected.
- Gross income was \$36,000 over budgeted amounts.
- Pastor Heather's and Pryncess' hard work resulted in bringing in more income which helped decrease the loss.
- Pledges for 2024 are up and we have a few new pledges.

Our church's financial health is improving and the donation of the Smith Scholarship funds this year plays a big part in that. The entire congregation is extremely thankful for this gift entrusted to us 30 years ago. Based on recommendations from the Scholarship Committee and Dan Stuart, these funds will allow us to continue the Scholarship program, to have a building maintenance and repair fund, an endowment fund, and an operations fund. In December, Andy Kovats, George Whitt, Rich Baker, and I met with a financial advisor from UC Funds to determine how and where best to diversify these funds. We feel confident that the guidance from UC Funds will help the money grow.

We presented some ideas to the congregation at two Fellowship potlucks. The Committee's recommendations are included in this report.

In June we had Scholarship Sunday and recognized the students who are recipients of the Frank and Salome Smith Trust, Nathan Hudson, Atticus Baker, Kendyl Born, Trent Born, and our newest recipient Rebecca Davis, and their families.

We have been receiving this money since 1994 and have given scholarships to over 100 students from our church. This year we gave out \$19,500.

I want to thank Arlene Penman, Sue Jones, and Dan Stuart for all their help this year. I am looking forward to working with them next year.

### Pantry & WestSide Cares Lay Representative Annual Report

Our congregation supported WestSide CARES this past year with the following donations:

- 280 packages of notebook paper and \$425.00 was given to WestSide CARES for the Backpack program.
- \$565 was given to provide Thanksgiving Dinners.
- We adopted a family of four giving them \$500 in gift cards for food and gifts.
  - Adopted a second family of three, giving them \$425 for food and gifts. The money for this second family was money not delivered to a family last Christmas because they unexpectedly were not available.
  - Both families received a quilt from Women's Fellowship.
- Our church family has supported the food pantry with money and countless bags and boxes of food.
  - This year, our pantry served...
    - 621 family units, 848 adults, 243 children, and 116 seniors.
    - A total of 1207 individuals!
  - Last year we served 747 people from 337 households. This year we saw an increase of 38% in persons served.

# ADOPTING CHANGE TO THE CONSTITUTION AND BYLAWS Part 1

#### **CHANGE TO ARTICLE VIII: MINISTER(S)**

#### **Current: Section A. Election, Duties, Performance Review**

2. Duties. The Minister shall have charge of the spiritual welfare of the Church, including functioning as the Chief Administrative Leader of the Church with the assistance of its various organizations. All paid staff persons, except the Bookkeeper, shall be under the Minister's direction. In cooperation and consultation with the Church Council the Minister shall:

#### **Proposed: Section A. Election, Duties, Performance Review**

2. Duties. The Minister shall have charge of the spiritual welfare of the Church, including functioning as the Chief Administrative Leader of the Church with the assistance of its various organizations. All paid staff persons, except the Bookkeeper, shall be under the Minister's direction. In cooperation and consultation with the Church Council the Minister shall:

## **Community Congregational Church - Designated Funds History, Part 1**

4/30/2023

#### Children's Bell Choir

Started in 2019 by Robyn Firth and Danny White to get kids involved in music and to learn handbells. Suspended during Covid and not started again.

#### **Good Samaritan Fund**

Started to help people who asked for gas money, rent assistance, etc. Major activity in 2019 and 2020 when we had a person in the congregation going through health problems. Rather than give money directly to her, some people would give to this fund and we would give the money to her.

#### **Art Fund**

Art Committee sometimes had a sale of recycled art – paintings, etc that people no longer wanted. They would bring them in and sell them to others. Not active for several years. The major person on the art committee (an informal group) moved away.

#### **Missions Fund**

The Missions board would have a Spring Tea each year to raise funds for various missions projects – One Nation Walking Together, West Side Cares, etc. The latest activity is Will Hinkley memorial funds deposited here (per Jan's request).

#### **Westside Cares Fund**

Donations to this fund are for the Westside Cares "backpack project" and Thanksgiving and Christmas gifts to families. For the last few years the backpack supplies have been donated. Arlene is principally in charge of these projects.

#### **Youth Fund**

Started years ago to supplement youth activities, including vacation bible school, field trips, etc. No youth group, so no expenses for several years.

#### **Memorial Fund**

Money given in memory of members. Families are supposed to be contacted to discuss what they want done with the donations.

#### **Building Improvement Fund**

Donations to be used for major building improvements. Last major improvements were to replace the ice maker and upgrade the sound system.

### **Waldo Canyon Fund**

When the Waldo Canyon fire happened, the UCC national office sent us money to help the community. The Black Forest church received funds as well, but they weren't impacted by this fire so they sent their money to us. I think it was about \$1,500 each(?) but not sure. We helped one person with some rent assistance and another person with some utilities, but not much else. When the Black Forest fire happened the next year, we didn't send the Black Forest church back their money.

#### **Tresouthick Fund**

Marion Tresouthick's will designated \$50,000 to the general fund (I think) and \$25,000 to the church to be used for the youth program. We put the \$50,000 in the investment fund and we were using the \$25,000 to supplement the cost of having Claire Twomey as our youth minister.

# The Story of Our Proposed Budget for 2024 Part 1

#### by Rev. Heather McDuffee

"Give, and it will be given to you. A good measure, pressed down, shaken together, running over, will be put into your lap; for the measure you give will be the measure you get back." Luke 6:38

Every budget has a story. Our proposed budget's story for 2024 is one of Life (with a capital L) for Community Congregational Church. This year will be a time of providing strong structures to support growth, better retaining new folks, nourishing existing members, and meeting spiritual needs. We will continue to make significant strides in three areas of ministry: WORSHIP, COMMUNITY, and ECONOMIC SUSTAINABILITY.

For the past 15 years or more, our church has been running a deficit budget. As a way to fill in the gap, we have been dipping into our investments. Those investments are depleting in the very same year that the 30-year Frank and Salome Smith Trust is released to us. The world is very different than it was 30 years ago. And yet, the Smiths had the foresight and the generosity to give a gift that had time to grow and sustain us today... right on time.

Below is a bit of the narrative of WHY we are doing what we are doing in our budget. We need a "HOW", or a strategic plan so that we can wean ourselves off of the financial dependency we have had over the years. We must envision what it would look like to be fully financially responsible for ourselves as Christians in a faith community we love. We have the resources and I know we can accomplish this.

### **WORSHIP**

This past fall and winter, our Sunday morning worship continued to attract more newcomers. Worship attendance was up from an average of 30 when I first arrived to an average of 45 each Sunday, with a high of 70 on Easter and 72 on Christmas Eve.

Music is so important to our worship life together. This year, our music program has taken two big hits: Stevie Astley's retirement and Susan Doherty's resignation to take on a larger position at First Community Church. A small search team assembled in January to conduct interviews/auditions for a Director of Music. We had two interested candidates with only one interviewing and auditioning. We are incredibly hopeful that our new Director of Music, Jerry McCauley, will move our hearts and spirits in worship, while also engaging members in their talents and attracting new people.

Your pledge at work might make way for...

- An octogenarian who has seen too many things change in her lifetime and wants to sing familiar hymns and have a comforting place for her grandchildren. She knows her church will be here for her, even if she can't physically attend, and especially when she dies.
- An empty-nester couple who is looking for a deep spiritual well to ask questions about purpose, faith, and justice. They are looking for a church that has sermons to think about throughout the week, uplifting music, is open to all people on all walks of life, and yet has roots in tradition.

## **Narrative Budget for 2024 Part 2**

• A young adult who visits, hoping he isn't the only person under 40 and isn't mobbed for his youthful energy. He finds permission here to express himself through music.

**Budget Total: \$101,356** (Includes the music director, musical instrument upkeep, music ministry budget, pastor's salary, including pension and employee taxes)

#### **COMMUNITY**

This year, we reprised community outreach efforts through our participation in the Fruitcake Toss, the Carnivale Parade, Community Potluck, and Trunk or Treat. We offered new events, such as A Community Christmas, the Out Loud concert, and two J. Chang-Tablada concerts. We welcomed 7 new members, with people already lining up for the Spring Member gathering. "I feel welcomed in this place," people have said over and over. It is clear that people need a church like ours—will they hear about us?

In 2024, we will begin to fund a Director of Operations who will help us fund our ministries in new ways. Our Director of Operations will further develop our advertising and other publicity materials, develop our spaces for community uses, and capitalize on outreach opportunities both in media and in the community, etc.

Our Community Outreach lay leader will continue to plan and implement our increased presence in the community.

As Christians, part of our community will always be "the least of these". Not only are the recipients at the food pantry, Westside Cares, and The Place part of our community, but missions is a non-threatening way for new people to engage in our church's mission. Kingdom building is a community bonding experience. We aim to increase our visibility in the community to make Community Congregational Church a household name as well as to build a welcoming and loving culture in which we are comfortable inviting our friends and others to church.

Your pledge at work might make way for...

- A transplant from the Midwest who finds himself in the mountains of Manitou. He doesn't know a soul in town but finds us on our website and makes friends while serving at the food pantry.
- A neighbor whose son is gay and who doesn't know a church as open-minded as ours existed. She comes to church on a Sunday and hears a layperson share her stories about coming out. The woman is moved to tears. She now knows that "religious progressive" is not an oxymoron. She comes regularly to worship and wants to join the church.
- Someone newly sober finds himself depressed every December. They are invited to our church by one of our members and they begin new recovery groups at the church.

**Budget Total: \$58,250** (Includes the Director of Operations, internet, administrative expenses, and community outreach budget.)

**Narrative Budget for 2024 Part 3** 

#### **ECONOMIC SUSTAINABILITY**

Our leaders on Church Council were challenged to increase their giving by 1% more this year. "The 1% Challenge" was extended to all of our members to increase our faith in a future that we cannot yet see. Our collective pledged giving increased by 13%!! Way to go, Community Cong!! Of course, even with our increased giving, a small congregation can't cover our budget. Until we grow the number of people in our pews, we must get creative about what capacities we have for financial sustainability. In 2023 and 2024, we are generating multiple streams of income. The strongest income-generating asset our church has is our property.

We start with our parking lot. We rented our parking lot over the summer to the city who also striped our parking lot (a gift worth over \$5,000). From June to December, we earned \$11,087 from our parking lot. We now have parking signs with a QR code for people to pay us for parking. And it's working!

We have several renters in our building in 2024. From a meditation group on Saturday mornings to the Pike Peaks Bulletin, we are now generating \$8,000 that goes into our general operating budget. We will continue to build these relationships with people in our community and be good stewards of our beautiful space.

One-time events are increasing as well. In 2023, we had two weddings, five funerals, one family reunion, and a senior recital party. These events generated over \$4,000. We will increase these one-time events in 2024.

Because of the innovation and wisdom of Salome Smith, we can dream oa future with hope. In 2024, we are receiving this 30-year trust of \$650,000. The congregation will be voting on how we will invest these funds to sustain us into the future. And in 2024, we will be encouraging people to contribute to our endowment in similar ways.

Money is only ONE resource we have. Most church revitalization experts say that growing churches have parishioners who are engaged beyond the worship hour. When pastors do all the work, the church dies. I have already located some areas of the church to plug in passionate people. We are all invited to find that place of meaning and purpose. Many of you filled out the Engagement Worksheet included in your Stewardship packet. We have gathered the information that will connect people with meaningful ministries.

Your pledge at work might make way for...

- A young bride and groom looking for a place for their wedding and find that our church is the perfect place to put down roots for their future.
- A prominent leader in Manitou who leaves \$50,000 to Community Congregational Church in his will because of how open we are in our theology and how we support Westside Cares.
- A Manitou business owner who wants to lease four parking spots for his employees so that they have safe parking when they end their shifts at night.

During July and August, the Scholarship Board solicited comments from the congregation regarding the potential uses of the Smith Scholarship funds once those funds (approximately \$640,000) are received by the church in 2024. The Scholarship Board has reviewed the comments received and the surveys returned. Those comments are summarized as follows:

- 1. Members value the long history of the church in the community and that it's welcoming to all.
- 2. Members value one another.
- 3. Members value Pastor Heather and want to support her.
- 4. Members love the sanctuary and music and they value the fellowship hall.
- 5. Keeping our physical property in good repair and appearance is a high priority.
- 6. Having a scholarship program has been beneficial. It should continue to be available in some form for members and their children, if possible, balancing that desire with the financial needs of the church.
- 7. Scholarships and capital needs are easier goals for fundraising campaigns than salaries and other operational expenses.
- 8. Our Bedrock Beliefs and Core Values are still applicable to our Church.
- 9. The need for prompt action to address financial stability is recognized.

#### Committee Recommendations for the Smith Funds:

- 1. Scholarship Fund.
- a. Create a modest scholarship fund of \$50,000, to continue to be administered by the Scholarship Committee. For convenience and ease of management, The Scholarship Fund (The Fund") may be invested with the church investment fund, but The Fund and its earnings should be designated only for church scholarships.
  - b. Ask members to enhance The Fund over time through legacy and other giving.
  - c. Scholarship funds should be granted only to church members or children of members.
- d. Scholarships should be limited to a one-time gift of not more than \$2,500. This scholarship amount may be modified in the future, depending on the size of The Fund and the number of applicants.
- e. Current or prior Smith Scholarship recipients are eligible to apply for a scholarship from the Fund, so long as they have received not more than three years of funding from the Smith Funds.
- 2. Maintenance Fund
- a. Create a Maintenance and Repair Fund of \$160,000 (25% of the Smith funds) to address the physical maintenance needs of the church.
- b. The Church Council/Trustees should create a list of short, medium, and long-term capital needs (e.g. 1 year (immediate) needs; 5-year needs; and 10-year and beyond needs) to be addressed by this fund. The list should be reviewed, updated, and approved on an annual basis.

### **Proposal for use of Smith Trust Funds** Part 2

- c. Maintenance needs on the list should be presented to the congregation as sponsorship opportunities and fundraising campaigns.
- d. The Maintenance Fund should be utilized <u>only</u> as matching funds, following such campaigns.
- e. Consider that "wish lists" can use up the funds quickly. Many "nice-to-have" capital needs, such as new windows in the parsonage or AC for the Fellowship Hall could/should be funded by specific campaigns/targeted gifts/legacy giving. We should also be asking if we've "done without," is a given expenditure really needed at this time of economic uncertainty?

#### 3. Outreach and Programs

Emphasize the "community" in Community Church. Invite them in. Our focus should be on Manitou and Westside activities/events/sponsorship/support/mission. Let the community see we're involved.

- a. A short-term Outreach/Community-Visibility Campaign should be established. A \$1,000 gift has been received by the church to initiate this effort. This gift should be enhanced by \$5,000 from the Smith funds as well as by such other funds as may be solicited and received.
- b. The use of these funds should be directed by the Church Council to increase the visibility of the church in Manitou Springs and nearby areas. Possible starting points: Host community groups; sponsor music in the sanctuary and in the parks; support community projects like the library restoration, Hiawatha Gardens, the MSVFD, the PP Bulletin, adopt a park, etc. In short, be visible. It doesn't have to cost a lot. Such efforts have already started but, as an example, if \$100 is donated to a community project, multiple press releases and social media postings should celebrate that giving. (Note: Women's Fellowship already supports MSVFD and Miramont Castle. The church also supports Westside Cares. We should publicize that generosity.) We should also publicize our music. If the Church Council desires to attract the community to attend church or utilize the church for spiritual and other events, the community needs to know we're here. The Pikes Peak Bulletin reaches our target area and, likely, our demographic. The church's activities and community giving should be regularly featured in the newspaper.
- c. In a perfect world, without the concern for the church's current finances, Mission would be a separate category. If the church's mission to serve the community were clear and strong, we would be giving a portion of the funds to those needs and we would hope the returns would come back to the church in new volunteers and new members. Such are the challenges of faith. The suggestions for a modest outreach are a start of a new effort to focus locally and be more visible in the community.
- d. Only program enhancements that do not require additional church funding should be considered at this time. While no Smith funds should be allocated to programs, activities that encourage member participation in the church, as well as new member growth, should

be encouraged as long as they do not impact the budget. Bible study is an example of this, but any program that is volunteer-driven or self-funded should also be encouraged. Continuing to make the fellowship hall available at a reasonable cost for community activities is encouraged.

#### 4. Endowment

- a. Create an Endowment Fund for the church, starting with \$320,000 (50%) of the Smith funds.
- b. Ask for members to enhance the Endowment Fund over time through legacy and other giving. Such endowment giving should be celebrated at regular intervals and encouraged.
- c. For convenience and ease of management, the Endowment may be invested with the church investment fund, but the Endowment Fund and its earnings should be segregated in a separate line item.
- d. The principal of the Endowment should be maintained in perpetuity and not spent for any purpose, absent approval by a super-majority (e.g. 2/3) of the congregation. The earnings of the Endowment Fund should be designated for church operations and such other needs as the Church Council may determine.

#### 5. Operating

Given the current financial issues facing the church, the balance of the Smith funds (approximately \$105,000) should be utilized to help pay the ongoing operational needs of the church. With the current budget and expenditures, this approach is recognized to be, at best, a short-term band-aid. Immediate action is needed to strategically enhance visibility, endowment, and other giving, and targeting fundraising campaigns.
